

**Refund Cupid
Gold Mountain Casino**

Official Rules

1. Gold Mountain Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Gold Mountain Casino is giving away \$4,000 in cash during the “Refund Cupid” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Gold Mountain Casino Players Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: Employees of Gold Mountain Casino; Employees of the Nation prohibited from participating as set forth by any of the Nation’s policies, regulations, or laws; anyone who has been barred from any of the Nation’s gaming facilities; or any promotional sponsors.
3. Beginning, Thursday February 1, 2018 through Friday, February 16, 2018 Patrons will be able to earn entries for the drawings in the following ways:
 - A.) Patrons can also earn paper entries by winning \$50 or more in a spin on any participating AGS Machine.
4. On Friday February 16, drawings will be held from 6:00pm until 9:00pm. During which \$4000 in Cash will be given away as Sixteen (16) \$250. Ten (10) drawings will be from the Gold Mountain Players card random card in drawings and six (6) drawings will be from the hopper of AGS entry tickets.
 - A.) Patrons must be present and actively playing any machine with a Gold Mountain players card inserted in the machine at the time of each Random card in drawing to be eligible for random selection.
 - B.) Patron(s) must be present to win. Winner(s) will be announced and have two (2) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - C.) Limit of one (1) prize per patron for Random card in drawings and one (1) prize per patron for hopper drawings. Each patron is eligible to win one (1) random card in drawing and one (1) hopper drawing.
 - D.) Gold Mountain Casino’s casino management system and manual drawing system will be the sole determinant of each winner.
 - E.) Selected Patrons receiving offers via any direct marketing initiative will be able to redeem offers for additional entries and/or a single entry as specified on the offer.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
6. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winner must agree to sign a publicity release form before prize will be released.
7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
