

Double the Gold

Gold Mountain Casino

Official Rules

1. Gold Mountain Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Gold Mountain Casino is giving away over \$34,000 in cash and prizes during the “Double the Gold” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. Employees of Gold Mountain Casino, employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws, anyone who has been barred from any of the Nation’s gaming facilities, or any promotional sponsors.
3. Beginning July 1 and ending August 23 patrons will be able to earn entries for drawings in the following ways:
 - a.) Patrons will receive one (1) entry for every five (5) points earned on their Gold Mountain Casino Players Club Card. Partial entries will not carry over once drawings begin.
 - b.) Every Sunday and Monday throughout the promotion Patrons will receive double entries for every five (5) points earned on their Gold Mountain Casino Players Club Card.
 - c.) Patrons who are new Gold Mountain Casino Players Club Card members will receive five (5) entries upon initial enrollment.
 - d.) Entries will carry over until last drawing night on August 23, not including partial entries.
 - e.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.
4. Sweepstakes drawings will be held on July 12, July 26, August 9, and August 23. Cash drawings will take place from 6:00 pm to 10:00 pm and winners will be drawn every thirty minutes. Sixteen (16) cash winners will be drawn each night and cash will be given as; three (3) \$50, five (5) \$100, three (3) \$150, three (3) \$200, one (1) \$300 and one (1) \$500. On Friday, August 23 at 10:30 pm, one Grand Prize winner will be chosen and will receive one (1) 2019 Rockwood Roo Expandable Travel Trailer (valued at \$24,999.)
 - a. Patrons are responsible for activating their entries by properly inserting their Black Gold Players Club Card into an electronic gaming machine, removing their Players Club Card from the machine with in One (1) Hour of each drawing time.
 - b. Patron(s) must be present to win. Winner(s) will be announced and have three (3) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - c. Preliminary cash winners will have the opportunity to randomly choose their prize amount from a themed prop.
 - d. Limit of one (1) preliminary prize per Patron per night of this promotion.

- e. All participating Patrons will be eligible for the Grand Prize drawing on August 23.
 - f. Gold Mountain Casino's casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
 6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
 7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
 9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
