

Ghouls, Goblins, and Gold

Gold Mountain Casino

Official Rules

1. Gold Mountain Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Gold Mountain Casino is giving away \$6,500 in cash during the “Ghouls, Goblins and Gold” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Gold Mountain Players Club Card Member, with complete and accurate account information, to participate. The following entities are not eligible to participate or win during the promotional activity: employees of Gold Mountain Casino, employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws, anyone who has been barred from any of the Nation’s gaming facilities, or any promotional sponsors.
3. On Wednesdays, October 9 and 23, 2019, Gold Mountain Casino will be holding **random Hot Seat** drawings from 6:30 p.m. to 10:00 p.m. Each night, **a total of \$3,250** in cash will be awarded to eighteen (18) winners as: three (3) \$50, three (3) \$100, four (4) \$150, four (4) \$200, two (2) \$300 and two (2) \$400. Winners will have the opportunity to randomly pull their prize amount from a Spooky Cauldron.
 - a.) Patrons must be present and actively playing with their Gold Mountain Player’s Card at any electronic gaming machine at the time of each drawing to be eligible to win.
 - b.) Winner(s) will be **announced** and have two (2) minutes to respond. **However, if the announced winner does not respond within the allotted time,** a new winner will be drawn.
 - c.) Limit of one (1) prize per patron, per promotional night.
 - d.) Gold Mountain Casino’s **casino management** system will be the sole determinant of each winner.
4. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form when applicable provided by the Chickasaw Nation.
5. Acceptance of prize constitutes winner’s permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before the prize will be released.
6. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from gameplay, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.

7. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and forfeiture of any prizes.
8. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
