

Hunting the Gold

Gold Mountain Casino

Official Rules

1. Gold Mountain Casino is a governmental enterprise of the Chickasaw Nation, (“Nation”) a federally recognized sovereign Indian tribe. Gold Mountain Casino is giving away \$10,000 in cash and prizes during the “Hunting the Gold” promotion.
2. Patrons must be 18 years of age or older with a valid photo I.D. and must be a Gold Mountain Players Club Card member, with complete and accurate account information, to participate. The following individuals or entities are not eligible to participate or win during this promotional activity: employees of Gold Mountain Casino, employees of the Nation prohibited from participating as set forth by any of Nation’s policies, regulations, or laws, anyone who has been barred from any of the Nation’s gaming facilities, or any promotional sponsors.
3. Beginning November 1, 2019 through November 21, 2019, Patrons will be able to earn entries for drawings in the following ways:
 - a.) Patrons will receive one (1) entry for every three (5) points earned on their Gold Mountain Casino Players Club Card. Partial entries will not carry over after drawings begin. Entries will not carry over to second drawing night.
 - b.) Every Sunday and Monday throughout the promotion Patrons will receive double entries for every five (5) points earned on their Gold Mountain Casino Players Club Card.
 - c.) Patrons who are new Gold Mountain Casino Players Club Card members will receive five (5) entries upon initial enrollment.
 - d.) Patrons in possession of a valid, applicable direct offer distributed in association with this promotion are eligible to redeem these offers for additional entries.
4. Drawings will be held on Thursdays, November 7 and 21, 2019 from 6:00 p.m. to 9:00 p.m. and winners will be drawn every thirty minutes. Seventeen (17) preliminary winners will be drawn and cash will be awarded as; five (5) \$100, five (5) \$200, five (5) \$300, and two (2) \$500. At approximately 9:30 p.m. each drawing night, one (1) Grand Prize winner will be drawn and receive one (1) \$1,000 Gift Card to Academy Sports and Outdoors.
 - a. Patrons are responsible for activating their entries by properly inserting their Gold Mountain Player’s Club Card into an electronic gaming machine, and removing their Players Club Card from the machine with in one (1) hour of each drawing time.
 - b. Patron(s) must be present to win. Winner(s) will be announced and have three (3) minutes to respond. However, if the announced winner does not respond within the allotted time a new winner will be drawn.
 - c. Preliminary cash winners will have the opportunity to randomly choose their prize amount from a themed prop.

- d. Limit of one (1) preliminary prize per Patron, per night during this promotion.
Limit of one (1) Grand Prize per Patron, for the duration of the promotion.
 - e. Gold Mountain Casino's casino management system will be the sole determinant of each winner.
5. Winner(s) are responsible for all applicable taxes. Winners will receive a W2-G and/or a 1099 tax form, when applicable provided by the Chickasaw Nation.
 6. Acceptance of prize constitutes winner's permission for Nation to use his/her likeness or name for publicity or promotional uses without compensation or notice. Winners must agree to sign a publicity release form before prize will be released.
 7. Any situation or dispute not covered by these Official Rules will be resolved by Nation in a manner deemed by Nation to be the fairest to all concerned. Any such decision shall be final and binding on all Patrons. In addition, Nation reserves the right to void any entry, and/or change, cancel or modify this promotion at any time without notice. Upon any dispute resulting from game play, Patrons may file a Prize Claim with the Chickasaw Nation, Office of the Gaming Commissioner.
 8. Participation in this promotion is an agreement to abide by these Official Rules. Failure to comply with these Official Rules may result in disqualification and a forfeiture of any prizes.
 9. Participation in this promotion and/or tournament further constitutes the affirmative consent of each Patron to the exclusive jurisdiction of the Nation, its regulatory bodies and courts without limit to time or event, which shall govern this promotion.
